

Appendix 1: Customer requirements specification

General requirements and explanations

All requirements must be answered from Contractor to be compliant for an assessment from Customer. The spreadsheet shall be delivered together with the offer from the Contractor. The Contractor can answer with numbered attachments.

Requirement code.

The Agreement, clause 1.1 Scope of the Agreement

If the deliverables shall function together with the Customer's current technical platform, this shall be stated here.

The Agreement, clause 2.7 External legal requirements
